I have received the following response from our highways area manager, which I believe sets out what you need to do. He states as follows:

It isn't necessarily straightforward as in theory that is not a valid reason for closing a road under the legislation available. The Road Traffic Regulation Act has sections that allow for roads to be closed for works or safety and a different section for events (e.g. such as is used for the closures around Goodwood events). However the Highway Network and Traffic Manager (Jeff Elliott) has advised that if an application is submitted to the Streetworks Team detailing the proposal with a plan then they can consider it and advise if it will be supported. One of the key considerations will be making sure that emergency and essential access to properties is available so any proposal will need to reflect this. How the vehicles are parked so as not to obstruct the footway or cause damage to the verge will also need to be considered.

I suggest LPC send an email about their proposal (including a plan and information on what is being proposed) to events@westsussex.gov.uk who can then advise on whether it will be supported, and if so what legislation would be appropriate and therefore which application process to take. They will hopefully also be able to advise on costs, as this may be dependent on the type of closure processed.
